10. Council meeting recessed and Public Hearing was called to order at 7:35 p.m., by Mayor Chris Goertzen. Public Hearing was to consider By-Law 2087, being a redesignation to the Official Community Plan.

#### By-Law 2087 - Official Community Plan

80 Brandt Street

Owner: Gerald & Shirley Klassen

Applicant: Association for Community Living - Steinbach Branch

Purpose: To re-designate the property from Residential Policy Area to Commercial Policy Area.

The applicant is proposing to re-designate the property to allow for office space for enVision Community Living.

- 10.1 City Manager, Troy Warkentin, introduced By-Law 2087 and reported that notices pursuant to The Planning Act had been completed.
- 10.2 One item of correspondence from Jeremy Neufeld, 114 Westwood Street, has been received, voicing concerns of an increase in traffic in the area; specifically traffic volumes at the intersection of Woodhaven Avenue and Brandt Street.
- 10.3 Correspondence has been received from Manitoba Municipal Relations Community and Regional Planning Branch indicating no concerns were received from commenting agencies.
- 10.4 A petition signed bearing 46 names was received.
- 10.5 Correspondence has been received from Brian and Cindi Patrick, 91 Autunmwood Drive.
- 10.6 Ms. Jeannette DeLong, 66 Giesbrecht Street, on behalf of enVision Community Living (enVision) was present at the hearing and provided the following information.
  - -enVision has been a part of the community for over 60 years.
- -enVision Community exists to inspire equality, inclusion, and the value of all people. Providing a range of supports and services for people living with an intellectual disability.
  - -They serve over 500 people who live with a disability.
  - -Employ over 500 employees, have 26 residential homes in Steinbach.
- enVision's current office at 84 Brandt Street is the main administration office was built in 2008 and has blended well with the neighborhood. The office is in need of more space. Over the last1.5 years enVision has looked at several properties throughout the City and found the property across the street at 80 Brandt Street to be best suited. This site will accommodate required parking (4 stalls) and overflow parking can be used at the current location.
  - Rezoning of the property will not be a detriment to the City.
  - -The presenter was prepared to answer questions.
- 10.7 Ms. Lisa Gretsinger, 109 Autumnwood Drive, was present at the hearing objecting to the re-designation to By-Law 2087 and rezoning By-Law 2087. She has been a resident in the area for 23 years and did not choose to live in a commercial zone. She does not want C2 zoning in her back yard. She voiced concerns of traffic, noise, additional truck traffic and snow clearing.
- 10.8 Mr. Bob and Ms. Valerie Frey, 72 Brandt Street, were present at the hearing objecting to the re-designation. They iterated the stellar reputation that enVision has. He questioned if there was a different designation that could be more suitable for the intent of the use of the property.

- 10.9 Ms. Karen Loewen, 68 Brandt Street, was present at the hearing objecting to the re-designation and rezoning. She voiced concerns of traffic, safety and well-being of citizens, noise increase and environmental factors. The business will devalue the properties in the area.
- 10.10 Mr. Art Poetker, 79 Autumnwood Drive, was present at the hearing objecting to the By-Law. He voiced concerns of property value, and the increase of traffic.
- 10.11 Mr. Brian Brunelle, 107 Autumnwood Drive, was present at the hearing objecting to the by-law. He applauded enVision for the work they do for the community. He voiced concerns of traffic at the intersection of Brandt Street and Woodhaven Avenue. He expressed safety concerns of people crossing Brandt Street.
- 10.12 Mr. Gerald Klassen, 80 Brandt Street, was present at the hearing supporting the by-law. This location of the property would complement their existing property and be a good fit. There is access off of Woodhaven Avenue to accommodate parking.
- 10.13 Mr. Ross Jardine, 85 Autumnwood Drive was present at the hearing objecting to By-Law 2087 and By-Law 2088. He voiced concerns of the increase in traffic and the decrease in property values. Questioned of a second floor could be added to the existing building.
- 10.14 Ms. Jeannette DeLong, returned to the podium to address questions or concerns.

  -The issue at hand cannot address the future of what will happen to the zoning on Brandt Street. They are seeking rezoning of an individual lot.
  - -The current building structure cannot sustain a second floor.
- -Numerous locations and buildings have been looked at, however none were found.
  - The intention of the rezoning is to add additional office space.
- 10.15 There being no further discussion, Council meeting re-opened at 8:27 p.m.

<u>Variance V-2017-26</u>

260 Park Road West

Owner: 4191994 Canada Ltd. Applicant: Oliver Kopp

The applicant is requesting to waive the requirement to hard surface the parking area of the subject property.

- 13.1 City Manager, Troy Warkentin, introduced Variance V-2017-26 and reported that notices pursuant to The Planning Act had been completed.
- 13.2 No letters of correspondence were received.
- 13.3 Mr. Oliver Kopp, the applicant was present at the hearing and provided that customers are coming off of a gravel road and asked not to pave the parking lot. He provided that when Park Road West would get hard surfaced he is prepared to pave the parking lot at that time.
- 13.4 Mr. Oliver Kopp was prepared to answer questions of council.
- 13.5 Administration provided that the lot grading and servicing plan submitted by the owner at the time of development showed the required parking and the parking aisle that was to be hard surfaced. The plans were approved on that basis by the City in November of 2015. The work to date is incomplete and remains outstanding.

- 13.6 Mr. Kopp returned to the podium and apologized that he did not know of the outstanding issue. He would have applied for a variance prior to the development if he had known if paving the lot was a requirement. He felt it didn't make sense to pave the lot at his time.
- 13.7 There being no further discussion, Council meeting re-opened at 7:40 p.m.

City Manager, Troy Warkentin provided that the City currently owns approximately 40 acres of land leased by the Steinbach Fly-In Golf Club for the driving range and a portion of the front nine of the golf course. In 1986, the City and the Golf Club entered into a long term lease of this land. The golf club has proposed to sell to the City an additional 40 acres adjacent to the property already owned by the City; and to enter into a long term lease agreement of the subject property back to the Golf Club.
- 15.1 Discussion of Council was followed by resolution listed.

BE IT FURTHER RESOLVED that the signing officers of the City of Steinbach be authorized to execute all required land transfer documents;

18. City Manager, Troy Warkentin provided a report regarding to Home Street North drainage swale. Council received a request from residents along Home Street North for a review of the Home Street North drainage swale on the street. Residents had voiced concerns on water issues and ice build-up on the street during freeze up and spring thaw. City Manager provided that City staff has monitored and maintained the area more frequently due to the concerns identified. The area was also reviewed if there were any alternatives to address concerns noted. City manager provided a brief history of the area and several options were provided.

City Manager concluded the street currently has an open-drain configuration. It may not be the preferred option however is the most practical and cost-effective option for the area. The City is completing more frequent inspections of the street, and is completing additional maintenance to keep the drainage channel clear so that the water can drain most effectively.

### R17-235 22. Councillor Zwaagstra, Councillor Siemens

BE IT RESOLVED that the City of Steinbach be authorized to borrow up to \$2,000,000.00 from the Royal Bank of Canada (*hereinafter referred to as "the Bank"*) during 2018 for operating expenses, and to pay or agree to pay interest thereon, or on so much thereof as remains from time to time paid, calculated at the Bank's prime interest rate per annum in effect from time to time minus 0.25% per annum, as well after as before maturity default and judgement, with interest on overdue interest at the same rate as the principal.

THAT the amount so borrowed with interest aforesaid be evidenced by either of the following means:

- (a) by one or more promissory notes under the seal of the corporation and signed by the Mayor and one of the following the City Manager or the Director of Finance thereof and given to the Bank; or
- (b) by overdraft on the account of the corporation with the Bank by cheques signed by the Mayor and one of the following the City Manager or the Director of Finance thereof.

THAT the Corporation hereby mortgages, assigns, transfers, pledges and hypothecates to the said Bank the taxes of the Corporation for the present year for municipal, school or the purposes of the Minister of Intergovernmental Affairs as additional security for the repayment of the amount so borrowed for any of such respective purposes.

THAT the Corporation shall deposit said taxes with the Bank as collected in a special account as collateral security for payment of the amount so borrowed and interest, but the Bank shall not be restricted to the said taxes for payment of the sum borrowed hereunder, nor shall it be bound to wait for repayment of said sum until said taxes are collected, or be required to see that they are deposited or applied as aforesaid.

THAT the amount so borrowed and interest shall be payable within the current fiscal year.

THAT the Mayor and one of the following the City Manager or the Director of Finance are hereby authorized to give to the said Bank in the name, on behalf of and under the seal of the Corporation as security for the moneys so borrowed, and interest thereon, a covenant or agreement containing a clause that all taxes levied or to be levied by the Corporation for the present year be and they are thereby pledged, hypothecated, mortgaged, transferred and assigned to the Bank as security for said loan and interest thereon and are charged as a first charge with repayment of such loan and interest, or a clause to like effect; and that said taxes shall be deposited forthwith on being collected in the Bank to the credit of the Corporation in a special account as collateral security for said advance.

- Correspondence regarding parking was acknowledged from Leonard Klassen. The following resolution resulted.
