CITY OF STEINBACH Regular Council Meeting January 17, 2017

MINUTES

- 1. Minutes of the Regular Council Meeting of City of Steinbach Council held on Tuesday, January 17, 2017, at City of Steinbach Council Chambers.
- 2. Mayor Chris Goertzen called the meeting to order at 7:30 p.m., with the following members of Council present: Councillors Earl Funk, Michael Zwaagstra, Jac Siemens and Susan Penner. Also present: City Manager, Troy Warkentin, City Clerk, Deb Rempel and Corporate Services Manager, Rhona Dundas.
- 3. Councillor Jac Siemens opened the meeting.
- R17-001 4. Councillor Funk, Councillor S. Penner RESOLVED that the agenda be adopted as amended.

- 6. City Manager, Troy Warkentin reported that the City has received The 2016 Steinbach Annual Traffic Count Program Report as submitted by MMM Group Limited. The traffic count and analysis program was conducted at 18 intersections in Steinbach, and included p.m. peak hour traffic volumes, daily traffic volumes (Provincial Trunk Highway PTH 12 and PTH 52 only), intersection analysis, 95th percentile left-turn lane requirements, traffic signal warrants, and pedestrian crossing control warrants.
- 6.1 The Steinbach Annual Traffic Count Program was acknowledged by City Council and discussion followed.
- 6.2 It was noted that copies of these annual reports are provided to the Province of Manitoba Infrastructure (MI).
- 6.3 Summary of the 2016 Traffic count program:
- (a) P.M. peak hour traffic volumes at both signalized and unsignalized intersections along PTH 12 have increased at an average annual rate of approximately one to three percent over the past 10 years.
- (b) Traffic volumes on portions of PTH 12 decreased when compared to 2015 volumes. This is likely due to construction on PTH 12 between Park Road and Loewen Boulevard which reduced the number of northbound and southbound travel lanes.
- (c) Three distinct peaks for traffic occur at the PTH 12 and PTH 52 intersection during a 24-hour period. The traffic peaks occur in the morning (7:30 to 9:30 a.m.), during noon hour (12:00 to 1:00 p.m.), and in the afternoon (3:30 to 5:00 p.m.).
- (d) The intersection of Loewen Boulevard at PTH 12 was at LOS E and was the only intersection that did not meet the target overall LOS of D, the cross-street LOS of D, and the through movement of LOS of C.
- (e) The majority of the existing turning lanes have adequate lengths for the number of vehicles making left-turns. The exceptions are the southbound approaches on PTH 12 at Park Road and Loewen Boulevard, and the eastbound approach at PTH 12 and Park Road. As these locations, queued traffic is forecast to exceed the storage capacity which could potentially result in turn volumes intruding into the through lane.
- (f) The most critical location where turning lanes are needed and not provided is Loewen Boulevard eastbound and westbound at PTH 12.
- (g) The MI signal warrant priority point threshold of 50 points is exceeded, combined with more than 75 vph on the cross-street, at PTH 52 and Industrial Road (165 points) and PTH 52 and Lund Road (88 points). This is the third consecutive year that traffic signal warrants were met at PTH 52 and Industrial Roade and the fourth time in five years the signal warrants were met at PTH 52 and Lund Road.

- (h) Based on TAC's Pedestrian Crossing Control Guide, a half signal is recommended for the unsignalized intersection on PTH 12 and Millwork Drive/Stone Bridge Crossing and a pedestrian corridor is recommended for the unsignalized intersection of PTH 12 and Friesen Avenue/Woodhaven Avenue.
