


NOTICE OF PUBLIC HEARING BY THE MUNICIPAL BOARD OF MANITOBA PROPOSAL TO ANNEX CERTAIN LANDS FROM THE RURAL MUNICIPALITY OF HANOVER TO THE CITY OF STEINBACH (BOARD FILE NO. 15E2-0001)

In accordance with Section 34 of The Municipal Act, the City of Steinbach has filed a written proposal with the Board to alter its boundaries by annexing certain lands from the Rural Municipality of Hanover.

This is to advise that the hearing adjourned on Monday, August 8, 2016 will reconvene on Wednesday, October 12, 2016 at 6:30 p.m. and, if required, Thursday, October 13, 2016 at 9:30 a.m. The public hearing will take place at the Royal Canadian Legion Branch No. 190, 294 Lumber Avenue, Steinbach, Manitoba.

The lands proposed for annexation are described as follows:

All Section 21, W $\frac{1}{2}$ of 22, NW $\frac{1}{4}$ of 24, SE $\frac{1}{4}$ of 25, SW $\frac{1}{4}$ and the south half and the southerly 100 feet of the north half of NW $\frac{1}{4}$ of 27, all 28, and S $\frac{1}{2}$ and NE $\frac{1}{4}$ and the south half of NW $\frac{1}{4}$ and Plan 31241 of 33 in Township 6-6 EPM; All sections 1, 4, 8, 9, NW $\frac{1}{4}$ of 10, E $\frac{1}{2}$ of 11, SE $\frac{1}{4}$ and NW $\frac{1}{4}$ of 14, W $\frac{1}{2}$ and NE $\frac{1}{4}$ of 15, all 16, and S $\frac{1}{2}$ of 17 in Township 7-6 EPM; and all Government Road Allowances adjacent to lands described above as shown on the map below:

Any persons affected by the proposed annexation may appear before the Board at the hearing.

A copy of the proposal is available for review at the Municipal Offices and the Municipal Board.

In addition, the Board requires that any party who intends to submit as evidence at the hearing any written material or other documents, shall file four (4) copies of that material with the Board and one (1) copy with each Municipality for public review, at least ten (10) working days prior to the hearing.

If a party wishes to have service in French, or requires assistance because of a disability, they must notify this office fifteen (15) days prior to the hearing.
