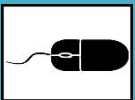

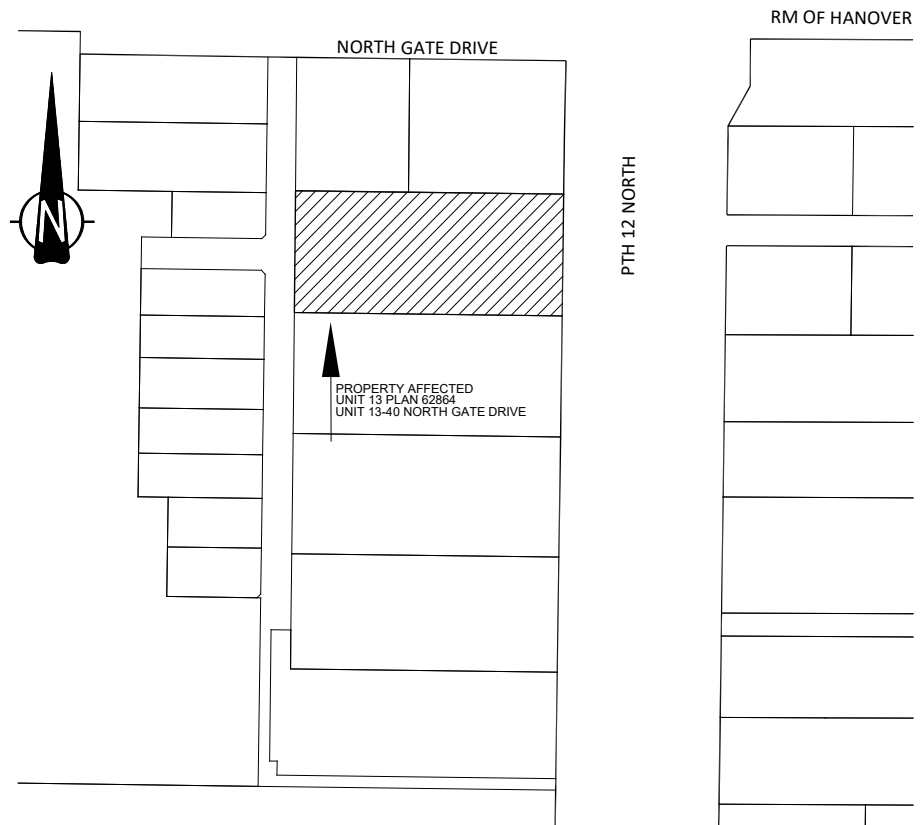

To utilize the property for the purpose of fleet services and other services related thereto.

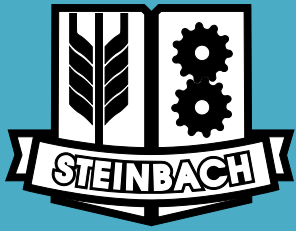

Commonly Asked Questions:

What happens at the hearing?

At the time and date noted above, the Mayor will ask the applicant to speak about his/her application and then Council will ask questions. After that, the Mayor will ask if anyone would like to speak either for or against the application.

Do I have to attend the hearing?

Your attendance at the Public Hearing is welcomed. However, you are not required to attend. If you are unable to attend, you may submit a letter and/or email to the City registering your concerns or objection prior to the Public Hearing. The applicant is required to attend the hearing to present his/her proposal and answer questions.

Why did I receive this notice?

As required under The Provincial Planning Act, and to involve the public in the planning of our community, owners of property located within 100 meters (328') of the above-mentioned property have received a copy of this notice.

Additional Information Re: COVID-19

The City of Steinbach is proceeding with public hearings, conducted openly pursuant to the requirements of the Municipal Act, and the Planning Act while ensuring COVID-19 protocols are being followed.
